

BLOOMFIELD ADULT ED WELCOMES STUDENTS FOR FALL 2025

Bloomfield Adult and Continuing Education is preparing free courses for its upcoming fall program, registering eligible students for GED high-school completion, English as a Second Language (ESL), and US Citizenship Preparation.

Academic classes are funded by a grant from the Connecticut State Department of Education, with additional support from Bloomfield Public Schools. They are offered to all Bloomfield residents, and materials are provided at no cost.

Twelve-week sessions begin walk-in registration August 25-27, with classes starting September 8. Classes meet at Carmen Arace Middle School, from 6 p.m. to 7:45 p.m.

Meetings are:

- Three nights per week for GED (Monday-Wednesday)
- Twice a week for ESL (Monday and Tuesday)
- Once a week for Citizenship (Tuesdays).

During the remainder of August, the Adult Ed staff are available to speak with potential students and answer questions. Walk-in registrations are scheduled for Monday, August 25, Tuesday, August 26 and Wednesday, August 27, from 6 p.m. to 7:30 p.m. The office is located at 390 Park Avenue in the Carmen Arace Middle School, Room 501.

NEED MONEY? CHECK OUT CONNECTICUT'S UNCLAIMED ASSET FUND...

All 50 states and the federal government have an unclaimed asset fund. Every day of the year checks issued by a corporate or government entity go un-cashed. People forget about stocks they owned, bank accounts they had as a kid, and often don't realize that they have been named a beneficiary in a life insurance policy, etc.

Connecticut, unclaimed asset fund is run by the state treasurer. It currently has over one BILLION dollars in it! I guarantee that if you or a family member doesn't have something in this fund, you will know somebody who does. Perhaps many people.

In 2022 I informed the town of Windsor Locks about several thousand dollars worth of unclaimed assets that they were able to collect. Nevertheless, many unclaimed assets over \$100 each for the Windsor Locks High School remain,



especially from Coca Cola. Both the towns of Bloomfield and Windsor have numerous instances of unclaimed assets for various entities within their borders such as their police departments, fire departments, boards of education, town halls, and various schools.

Windsor High School, especially, has many unclaimed assets, including several over

In January of 2022, I wrote an article about this fund, emphasizing the pathetically poor job that the state does in telling its citizens that it has their money. It was widely publicized. Additionally, a citizen of Bethany, CT, appeared in front of the state legislature and gave testimony to a committee excoriating the state for their lack of transparency on this issue. A streamlined, online method for searching for and claiming unclaimed assets resulted. Here is the site that you need to visit: ctbiglist.gov

You must enter something in the top line. I suggest that you enter just your last name if you're searching for an individual's unclaimed assets. Then scroll down and enter the name of your town or city. Then hit "Search." There may be multiple pages in the results. Keep in

mind that your name may appear on different pages, so look at them all. Search your business name, if you own a business.

If the asset is valued at under \$100, the entire amount to the penny will be listed; if over \$100, it will just say, "over

"Over \$100" may mean thousands, as it did for one of my family members. In 2022, I noticed unclaimed assets for the town of Haddam for over \$1,000. Subsequently, they got claimed. If you lived in another state, Google that state with the "unclaimed asset" phrase. If you used to have a different last name, search that as well. Happy hunting! Spread the

Just keep in mind: If you owe money to the state, you'd never hear the end of it. Plus, you'd be charged big interest on your debt and a penalty! However, if they owe you money from the unclaimed asset fund, you'll never hear from them unless you take action and search for yourself.

Since 2018, using Social Security numbers on the state income form, Rhode Island actively searches for its citizens to reunite them with their money listed in their unclaimed asset fund. Why don't we?

MEDICATION OVERLOAD: WHAT YOU NEED TO KNOW AND WHAT YOU CAN DO

Medication overload is a serious and growing issue in American health care, especially for older adults. It happens when someone takes so many medications that the risks and side effects outweigh the benefits. Today, more than 40% of people over the age of 65 take five or more prescription drugs, and nearly 20% take ten or more. This can lead to harmful health problems and even hospitalization.

Every day, hundreds of older adults are admitted to hospitals because of bad reactions to their medications. These reactions can include confusion, bleeding, falls, and even death. The more medications a person takes, the higher the chance of experiencing these problems. One major cause of medication overload is something called the "prescribing cascade." This happens when a new drug is prescribed

to treat the side effects of another drug, which then causes more side effects and leads to even more medications.

As people age, their bodies change, and medications can affect them differently than they did before. Drugs that were safe years ago may now be dangerous. For example, benzodiazepines, which are used to treat anxiety, can cause falls and memory problems in older adults. Another group of drugs, called anticholinergics, can cause confusion, fast heartbeat, dry eyes, and other side effects-especially when taken together. Also, trying to reach strict health goals, like lowering blood sugar or blood pressure too much, can lead to serious side effects such as dizziness, confusion, and even seizures.

To prevent medication overload, patients should keep an updated list of all the medications they take, including overthe-counter drugs and supplements. If someone is having side effects or struggling to manage their medications, they should ask their doctor for a "prescription checkup." This is a chance to review all medications and decide if any can be stopped or reduced. Before starting a new medication, patients should ask their doctor what the drug is for, how they'll know if it's working, when they should stop taking it, and what side effects to watch for.

Solving the problem of medication overload isn't just about individual choices—it's about rethinking how our health care system works. Right now, many doctors are trained to believe that more care means better care, which can lead to prescribing more medications than necessary. On top of that, communication between health care providers isn't always

smooth. One doctor might not know what another has already prescribed, and that can result in patients taking too many medications—sometimes without anyone realizing the risks. To truly fix this, we need better coordination, clearer communication, and a shift in mindset across the board.

Another big part of the problem is the role drug companies play. These companies often promote their products directly to both doctors and patients, which can lead to more prescriptions than necessary. It's tough for doctors to stay focused on what's truly best for the patient when they're being influenced by ads or sales reps pushing the latest medication.

To help change this, experts suggest giving health professionals better training—not just on how to prescribe safely, but also on how to reduce or stop medications when they're no longer needed. It's all about putting the patient's well-being first.

This process, called "deprescribing," helps doctors and patients work together to stop or lower doses of drugs that may no longer be helpful. Health care providers also need better tools to spot when medications might be causing harm, so they can act quickly to protect patients.

Limiting how much drug companies can advertise directly to consumers and doctors is another important step. When patients see ads for medications on TV or online, they might ask for drugs they don't really need. And when doctors are visited by sales reps, they might feel pressured to prescribe certain medications even if there are better options.

By making these changes improving communication, training, and reducing the influence of drug companies we can help prevent medication overload and keep patients safer.



BLOOMFIELD, I'M ALL IN!

Bloomfield, I'm All In! First, I'd like to thank you for putting your faith in me to serve our community over the last four years. It has been a great honor and privilege to be your Councilman. It's hard to believe that four years ago, I stood before you for the first time at the age of 23. Though I was young, I was ready to represent Bloomfield. I stepped forward as a young man eager to serve and willing to take on our challenges. I had a deep desire to give back to the community that has given so much

Today, I stand before you again, older, with more experience, more knowledge, and yet the same fire to stand up for our neighbors. Bloomfield, I am humbly asking for your support to re-elect me, Shamar Mahon, as your voice on our Town Council.

to me, the one I was born and

raised in.

Over the last two years, serving as the Minority Leader on the Town Council, I made it my duty to be your advocate. I consistently stood up to colleagues who did not have the community's best interests at heart. Many of you joined me in the fight to keep the Prosser name on our Town Center Library. I am proud to say I am the only member of the Town Council who consistently voted against renaming the Prosser Library.

I also represented you in our last budget by voting against the tax increase that is burdening so many of our neighbors. While all of my colleagues voted for the budget that is putting our most vulnerable residents at risk, I spoke out repeatedly about how irresponsible it was. In addition, I voted against the controversial \$4 million slush fund my colleagues attempted to slip into the budget. Bloomfield deserves Town Council leadership that is responsible with your tax dollars.

Moreover, I have been a consistent voice for public input and transparency. Over the past two years, we have seen a troubling erosion in opportunities for residents to participate in their government. Three glaring examples stand out:

- 1. Public comment cutbacks - Bi-monthly meetings with Citizens' Comments were reduced to just one, leading to more special meetings that do not allow for public comment.
- 2. Illegal "holiday" bonus

 The Town Manager received

- 3. Closed-door budget decisions The majority of the budget was determined in private party caucus meetings, keeping the public in the dark about the reasoning behind key decisions.



viding opportunities to working adults, who come from a wide variety of backgrounds and ages, the opportunity to attend evening classes. Students must be at least 18 years old to sit for the GED exam and will be registered for the test when they score "likely to pass" on practice tests administered by the GED classroom teacher.

Classes for non-native speakers of English are conducted in English, covering life/work communication skills and providing a foundation for acquiring everyday English language skills. ESL students are placed at beginning, intermediate and levels. advanced More advanced students can progress to Reading and Writing in the Adult Basic Education class (ABE).

A certified school counselor is on staff and available six hours per week to advise students about careers and college. All instructors hold current state certifications with endorsements in Adult Education. Class sizes are small, averaging 8-12 students.

In addition to state-mandated fields of study, Bloomfield Adult Ed offers a small number of supplemental or "leisure" classes. Examples of these classes, offered for a nominal fee, include Mindfulness Meditation, Beginning Ukulele, Crocheting, and Genealogy. The staff is open to receiving suggestions about potential new course offerings.

WHY I CHOOSE TO SERVE: A MOTHER'S PERSPECTIVE ON THE BOARD OF EDUCATION

I am a mother of two children who attend Bloomfield public schools, and I choose to serve on the Board of Education because I care, plain and simple.

When my oldest child started school in the district I was like many parents. I attended events, joined the PTO, and helped with homework. times, I volunteered to read to students and even sat in classrooms when extra help was needed. I tried to show up whenever I could. But over time, I started noticing things that didn't sit right. I'd hear from other parents who were frustrated or confused. I'd see families raise concerns but who felt like those concerns didn't go anywhere. I saw a gap between what parents were experiencing in real time and what was being acknowledged by the former administration.

It was in those moments that something shifted in me. I didn't want to just talk about the issue. I wanted to be part of the solution. I have always believed that real change starts close to home, whether it's showing up at school events, attending town forums, assisting with the town's youth sports, or simply talking with other parents. I felt responsible for bringing those everyday experiences into spaces where decisions are made.

Many of our parents are doing everything they can: working multiple jobs, caregiving, balancing it all. They don't always have the time or capacity to attend every meeting or keep up with every district update, but that does not mean they don't care. It means they need people who can represent them. People who can bring their feedback, positive or negative, along with real solutions, to the Board's and the superintendent's attention. I carry that role with care, humility, and a deep sense of purpose.

As a board member, I have worked to bring a real-life parent perspective into the decision-making process. I push for openness and honesty. I ask questions not to make noise but to make progress. I have advocated expanding our curriculum through more STEM opportunities, hands-on science learning, and programs that challenge students beyond the basics. I have pushed for clearer communication around decisions, especially how they affect our students, schools, and budget. And I continue to push for stronger parent engagement, including finding ways to reach families who can't always attend meetings. Whether through flexible outreach or more welcoming spaces, I believe we must meet parents where they are. because their voices matter.

Bloomfield is a beautiful and diverse community. Our children are talented, creative, and full of potential. But they need a Board committed to doing what's best for the children. That means holding ourselves accountable, asking questions, and listening—really listening to what families and the community are saying.

I didn't get involved for recognition or the spotlight. I got involved to make a difference. I'm a mother who loves this town and its children. I believe in public education and in doing my part to make it stronger.

Serving on the Board of Education hasn't always been easy, but it's been meaningful. Whenever I see a student grow, a teacher feel supported, or a parent feel heard, I know I made the right decision.

BLOOMFIELD, HAVING ALL THE FACTS LEADS TO BETTER DECISIONS

Bloomfield, Having all the facts leads to better decisions.

Mayor Danielle Wong recently urged Bloomfield residents to "choose facts over fiction." I agree, but believe there are a number of additional facts to be considered when analyzing our current town council's performance

Mayor Wong hand picked the current Town Manager, Alvin Schwapp and went to great lengths to get him on board as he does not live in Bloomfield. Since assuming the position in 2023, Mr. Schwapp has awarded Mayor Wong's aunt, the then Assistant Town manager, a total of \$50,000+ in salary increases, the new title of Deputy Town Manager and a new car. Why do you suppose he did this?

During a recent town meeting, one of our councilors accused a resident of having "white rage" as she walked out of a meeting. Rather than reprimand or censure this councilor for his racist outburst, the town manager defended him as simply being emotional. The Mayor immediately turned off the meeting audio so those online could no longer hear the event. Why do you suppose she did that?

On July 9, the State Freedom of Information Commission (FOIC) ruled that Town Manager, Alvin Schwapp, violated federal FOI law, by providing "conflicting and misleading" testimony and fined him. The town council continues to defend him and intends to use our taxpayer dollars to cover that fine.

The Town Council's recent budget included a \$4 million Economic Development Fund appropriation tucked inside the annual operating budget instead of being presented separately to voters, as required by the Town Charter and state law. This reduced our available funds with zero clear plans for where the money will go. Thankfully some of our residents have sued to correct this with a hearing scheduled in the coming weeks.

The council recently did a good job in performing their fiduciary duty and wisely invested our fund balance. This investment generated more than \$500,000 in income. However, rather than direct those funds to help lower our mill rate and offset the costs to our citizens, they put them in an all new slush fund to subsidize various projects around town. As of today, there are no clear plans for how or where to invest these dollars.

They have now steered an additional \$1M into the fund in this year's budget, still with no clear plans all of which has raised our taxes even more.

Moody's has placed Bloomfield on a list of just 109 municipalities in the entire country who have failed to provide their required 2024 state financial audits. This directly places our AA+ credit rating at risk. The state required audit was due on Dec 31, 2024 and is now beyond the extended 6 month extension period with no completion date in sight. Why was this not completed? Does this sound like a well run organization to you?

Very few of our residents are aware of the lawsuit, Los Cabos II Equity LLC v. Town of Bloomfield and Mayor Danielle Wong, filed in 2023. This suit alleges abuse of government power, defamation, and bad faith dealing on behalf of Mayor Wong and her administration. They claim our mayor and council used the threat of eminent domain to depress property value or Wintonbury Mall and dissuade tenant leases. This suit will most likely cost our town millions to settle.

The council recently placed a sexual harassment allegation, on an executive session agenda without a complaint and without charges for the sole purpose of slandering a political candidate. These same people have posted on facebook pages under "Anonymous" with the same intent. Despite a past investigation and dismissal they are still willing to lower themselves to this type of behaviour.

Backroom plans to rename our new Prosser Library after past mayor, Joe Suggs, angered a great many of our citizens. The Prosser family donated the land, original building and other funds in the year 1900 and continues to offer a fund that helps Bloomfield citizens in need today. The Mayor's plan, supported by Mr. Suggs led to protests, numerous angry town meetings and an FOIA filing. This ill-prepared scheme has done permanent damage to Bloomfield's reputation and to the Mayor's support from the town's citizens.

To the best of my knowledge the above facts are true. If any of you find a substantive error please let me know so I can retract or correct the statement. My goal here is not to spin anything but to provide our residents with a more complete picture of the council's actions.

And heaven help us all if they and their backers (the old political crowd that over the years has brought Bloomfield to the condition it is in today) get control – **expect tax abatements** [emphasis added], distribution centers, environmental degradation, and decline."

As I noted several months ago, Bloomfield's May Budget Referendum was merely a prelto the upcoming Democratic primary. The candidates and their backers exploited an unfortunate situation state-mandated revaluation, over which the Council has no control - to mislead and inflame residents about the FY 2026 Budget and this year's property tax increase.

Do you know who financed the "Vote No" campaign? Who paid for all those "Vote No" signs? Who were those Citizens for a Responsible Bloomfield Budget (the name of the PAC)? That name implies a grassroots group of activists. You probably believe that they collected lots of small contributions from local residents to pay for the campaign, right?

Wrong

All the donations came from three 'people.' That's it. Two of the donations were for "Vote No" cards. Valued in total at \$513.67, these came from former Probate Court Judge Steven Zelman (\$200) and Liquor Distributor Ross Hollander (\$313.67). Why was the former judge involved? Read on.

The major donation was all

those "Vote No" signs we saw around town – a donation valued at \$1,484.37. This 'In-Kind Contribution' came from Jolley 2, LLC. Who's that? And why is a limited liability company funding Bloomfield's Budget Referendum?

Jolley 2, LLC is the vehicle created by the developers who built the luxury apartments on Jolley Drive, The Residences at Wash Brook. One of those developers is Brian Zelman. Brian Zelman is Steven Zelman's son so the Zelman family essentially funded the Budget Referendum. Just the opposite of a grassroots, citizen-led initiative.

More importantly, the real question – why? What is to be gained? Why fund the attacks on our Council, Mayor Wong, and town staff? What do they want?

Very simple: Brian Zelman is unhappy that this administration has not been willing to provide special tax treatment, either abatements or 'tax fixing agreements' (i.e. your taxes may go up but his company's won't!), for his company's luxury apartments (the ones built and the ones he would like to build next door). Consequently he needs a different town council, one more sympathetic to his financial interests.

From an exchange with Mayor Wong in September 2024 (emphasis added in bold):

Brian Zelman (Sept. 18): We stabilized recently Residences at Washbrook (sic) and have been preparing to start the adjunct 40 units located next door at 57 Jolley Drive...Among the many challenges we face in building housing today, property taxes and the uncertainty related to them are the most significant. Their impact can make a project profitable or negate any gains made. We recently worked with the legislature to modify the enabling legislation for tax abatements...We have some hurdles to getting the 40 unit project started. I'd like to discuss in detail with you...

Mayor Wong (Sept. 25):
Thank you for reaching out...While we are deeply grateful for your development investment in Bloomfield, I've reviewed the financial data, and the numbers do not support an abatement. Our planning staff also agree with this assessment.

Brian Zelman (Sept. 27): Appreciate the responses and consideration...The other factor here is the uncertainty of the assessment and tax amounts. Our experience with 65 Jolley and the final assessment and tax diminished much the gains anticipated...Putting an abatement aside, certainty of assessment would go a long way to giving confidence in proceeding on a project with low projected returns. Most every other municipality we build in has agreed to a tax fixing agreement.

Then in February of 2025, to India Rodgers, Clerk of the Council:

Brian Zelman (Feb. 14): On behalf of Jolley 3 LLC1, I would like to be placed on the agenda for the March 3rd Governance, Policy, and **Economic** Development Subcommittee meeting. The nature of my presentation would be to present and discuss the hardships on our proposed development due to real property taxes, market conditions and therefore our desire for a tax fixing agreement...

As the Town Council never considered an abatement or tax fixing agreement, I think it's fairly easy to connect the dots and see the motives behind a West Hartford resident's involvement in our recent budget referendum. Why should luxury apartments (\$3,400 per month for a 2-bedroom) get a tax fixing agreement? What deals have already been made between Mr. Zelman and the folks who promulgated Citizens for a Responsible Bloomfield Budget (and yet another Democratic primary)?

As always, the question to ask is: who stands to benefit?






